

ORDINANCE NO. 291

AN ORDINANCE AMENDING TITLE IV, CHAPTER 1, ARTICLE 9, SECTION 9.04 OF THE CITY CODE OF NEWELL, IOWA, BY REMOVING NORTH FULTON STREET FROM THE DESIGNATED TRUCK ROUTES

BE IT ORDAINED by the City Council of the City of Newell, Iowa:

Section 1. Amendment.

Title IV – Traffic and Streets, Chapter 1: Traffic Code, Article 9 – Load & Weight Requirements, **Section 9.04 Truck Routes**, subsection **1(b)** is amended by **removing “North Fulton St.”** so that subsection 1(b) shall read as follows:

“b. South Fulton St. From US Highway 7 to West First (1st) St.”

Section 2. Through Trucks Route List (Updated for Clarity).

For reference and clarity, the updated list of designated truck routes under Section 9.04(1) is as follows:

1. **Through Trucks.** Every motor vehicle weighing five (5) tons or more, when loaded or empty, having no fixed terminal within the city or making no scheduled or definite stops within the city for the purpose of loading or unloading shall travel over or upon the following streets within the city and none other:
 - a. On First (1st) St. from Armstrong Road to Fulton St.
 - b. **South Fulton St. From US Highway 7 to West First (1st) St.**
 - c. On all of Third (3rd) St.

Section 3. Repealer.

All ordinances or parts of ordinances in conflict with this amendment are hereby repealed.

Section 4. Effective Date.

This ordinance shall be in full force and effect after its final passage, approval, and publication as required by law.
